## QUEST FOR THE TRUTH

November 20, 1981	Northern Territory Supreme Court quashes first inquest and orders a new one.
January 31, 1986	The matinee jacket believed to be Azaria's arrives at Alice Springs Court House.
June 2, 1987	After a fourteen month Royal Commission Justice Trevor Morling hands down his finding and clears the Chamberlain's of all guilt or responsibility.
October 29, 1982	Lindy, heavily pregnant, is found guilty of 1st Degree Murder and sentenced to life imprisonment. Michael received an 18 month suspended sentence.
August 24, 1980	Azaria's jumpsuit, booties, nappy & singlet were found but the matinee jacket Lindy said Azaria was wearing was not found.
December 13, 1995	The Third Inquest finds that neither Lindy nor Michael were in any way involved with Azaria's disappearance but the cause of death is left open.
June 11, 1980	Azaria Chantel Loren Chamberlain is born.
November 17, 1982	Kahlia was born in custody but went to live with foster parents Wayne & Jenny Miller and later Dr Owen and Jan Hughes.
February 7, 1986	Senator Bob Collins and reporter Frank Alcorta force an Inquiry to be called.
June 12, 2012	Coroner Morris announces that the cause of Azaria's death was by being taken by a dingo as the Chamberlains and the eyewitnesses claimed 32 years earlier.
August 17, 1980	At 9 weeks and 4 days Azaria was killed at Ayres Rock.
September 15, 1988	The Supreme Court of Darwin quashes all convictions and declares the Chamberlain's totally innocent and that Azaria was taken by a dingo.
February 24, 2012	Coroner Morris holds the fourth Inquest into the death of Azaria.
February 2, 1982	The Second Inquest starts with Lindy Chamberlain to trial on the charge of murdering Azaria and Michael Chamberlain as an accessory after the fact.
February 5, 1986	Lindy positively identifies the matinee jacket proving she had not lied.
February 20, 1981	Alice Springs Coroner Denis Barritt found that a wild dog or dingo took Azaria and no member of the Chamberlain family was responsible.
